Technology of producing knitted fabrics is one of the technological methods of producing fabric in the textile industry, and it has different characteristics from those fabrics produced by other technological methods such as woven and non-woven fabrics, buttonhole thread with knitted needles.

The experimental descriptive approach and statistical methods were used to compare the results and analyze them. The questionnaire was used as a research tool by implementing 12 different pieces of housing furnishings and supplements using manual knitwear in which the beauty of

One of the most important results of the research is that there is a statistically significant relationship between the possibility of manual knitting samples and enriching the aesthetic and functional values of some of the furnishing and housing supplements.

There are also statistically significant differences between the pieces executed from the point of view of the specialists, that according to the results of the arithmetic mean and the standard deviation, the order of the executed pieces came in terms of preference, in the first place segment No. (10) where the percentage of the three items came to 98.15% and then followed by the number (1.6), where it obtained the same percentage of 97.04%, followed by piece No. (4) with a percentage of 95.93%, and piece No. (9) got the percentage of 95.02%, and piece (11) got the percentage of 94.44%, and the piece of parchment (3) at the rate of 94.07% and the piece No. (2) on the percentage of 92.59%, and piece (5) on the percentage of 92.22%, and on segment (7) at 91.84%, and parcel (12) on the percentage of 90.74%, and parcel No. (8) on 89.26% Since all the pieces obtained more than 85%, the research hypothesis has been fulfilled that the formative values of the manual knitting samples can be used to enrich the aesthetic and functional values of some of the furnishing and housing supplements. The recommendations of the research came to expand the implementation of applied research
